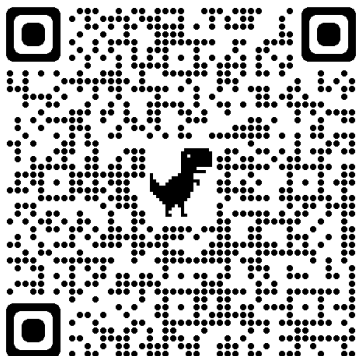

- 1:00 p.m. Pork Ribs (7 individual Pork Spareribs, only St. Louis Cut, Spare Ribs or Baby Back Ribs allowed)
- 2:00 p.m. Pork Butt only
- 3:00 p.m. Brisket (7 full slices)  
(Standard Turn-In Times Apply Up to 100 Teams)
- Jackpot turn-in times – Saturday Beans 10 a.m. Desert 11:00 am

1<sup>st</sup> thru 4<sup>th</sup> place finishers, in each category, cash payout.
